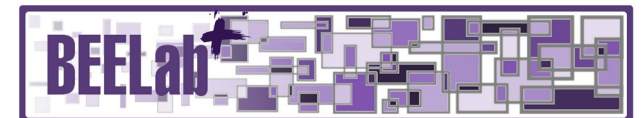

CALL FOR PAPERS

We invite submissions of papers from researchers across all areas of behavioural and experimental economics with a focus on addressing pressing societal challenges of our time, such as agents and firms behaviour in digital markets, climate change and environmental sustainability, technological change, social and economic inequality, social changes and the future of work, political polarization, global cooperation and peacebuilding.

How can we drastically reduce greenhouse gas emissions to contain global warming? What policies, technologies, and behaviours can ensure sustainable use of natural resources? How do we mitigate the impact of climate change on vulnerable communities? How can societies reduce economic inequality while encouraging growth and innovation? What are effective strategies for addressing racial, gender, and cultural inequities? How will automation, artificial intelligence, and robotics affect jobs, and how can societies prepare for these changes? How can countries balance economic needs with social inclusion and security concerns? How can societies curb political polarisation and disinformation in order to strengthen democratic institutions and rebuild trust in them? How can policies be devised that balance national sovereignty with global cooperation? What role should international bodies play in managing migration?

The above questions, along with many others, lie at the crossroads of economics, political science, psychology, and sociology, and strongly call for interdisciplinary collaboration. The workshop aims to bring together scholars, practitioners and policymakers interested in understanding decision-making processes and their implications for individuals, organizations and societies. Tackling them is a formidable but indispensable task for the present and future generations.
